Dear President Hopper:

Congratulations! The Board of Commissioners of the Associate Degree Commission met on April 18-19, 2013, and voted to reaffirm accreditation to Kennebec Valley Community College with opportunities for improvement in your business programs.

The Board of Commissioners commends Kennebec Valley Community College in providing quality benefits to its stakeholders. Rarely does the Board of Commissioners find a school where all of their full-time faculty own and operate businesses. The department's interaction with the community is likewise commendable. The Board of Commissioners commends you on meeting the standards with no notes or conditions for accreditation.

Opportunities for improvement indicate that the Standard has been met, and are suggestions to help move your processes from good to great. It is extremely rare that a school receives accreditation without opportunities for improvement given ACBSP's Core Value of Continuous Improvement and Organizational Learning, that "Business schools and programs should pursue regular cycles of planning, execution, and evaluation of every process and system. Ongoing improvement of these processes and systems leads to ever higher quality and student/stakeholder satisfaction." The opportunities for improvement in your programs are:

OFI on Standard 1, Criterion 1.3: Please improve communications with business advisory partners. This should provide valuable evidence to external stakeholders of your constant facilitation of leadership.

OFI on Standard 4, Criterion 4.3: By analyzing the data and implementing continuous improvements, stakeholders will benefit from the use of gathered data. Kennebec Valley Community College has hired a Director of Institutional Research who should prove useful in utilizing assessment data for continuous improvement, which is an important step in the ACBSP framework.

Your first Quality Assurance Report will be due on 2/15/2015, and every two years after that. It is not necessary to report on opportunities for improvement (OFIs). Your ten-year reaffirmation will be due in 2023.
