Your Goal	Giving Strategy
Buy low, give high– make a gift that costs you less than the benefit provided to KVCC; avoid capital gains.	Make a gift of appreciated stocks or bonds
Make a gift for the future that doesn't affect current cash flow	Arrange a bequest, share of estate residue, or retirement or insurance policy designation
Reduce tax liability now, gain additional income later.	Establish a charitable gift annuity.
Reduce gift and estate taxes and control timing of passing assets to your decedents.	Create a charitable lead trust that supports KVCC for a fixed period leaving the principal for your heirs.
Turn an often overlooked asset into a meaningful gift and eliminate income tax on retirement plan assets.	Name the KVCC Foundation as retirement plan or life insurance beneficiary.
