Previous experience, whether personal or professional, in the behavioral health or substance use treatment fields and spending time with individuals in various stages of recovery is a plus. The candidate should be compassionate, patient, sensitive, and mindful of the vulnerability of clients when their stories.

- Excel in communication, both oral and written
- Seek opportunities to go above and beyond
- Continuously demonstrate a willingness to learn
